

Independent Women Supports The No Subsidies for Gender Transition Procedures Act

May 7, 2025

Dear Members of Congress,

Independent Women applauds the introduction of the "No Subsidies for Gender Transition Procedures Act" by Representative Claudia Tenney. Independent Women fights for women and their loved ones by effectively expanding support for policy solutions that aren't just well-intended, but actually enhance people's freedom, opportunities, and well-being.

The No Subsidies for Gender Transition Procedures Act would direct the Department of Education to ensure that taxpayer dollars will not go toward so-called gender transition procedures via Medicaid, Medicare, the Children's Health Insurance Program, or the Affordable Care Act. It would also ensure that there would be no medical expense tax deduction for gender transition procedures.

While the bill applies to procedures for adults and children alike, it will additionally support President Trump's **executive order**, "Protecting Children from Chemical and Surgical Mutilation," which declared his administration will "not fund, sponsor, promote, assist, or support the so-called 'transition' of a child from one sex to another, and it will rigorously enforce all laws that prohibit or limit these destructive and life-altering procedures."

Indeed, gender transition procedures—including puberty blockers, hormones, and surgeries—are neither safe nor effective. Representative Tenney's bill ensures that no doctor will be able to profit from harm and that no taxpayer will be funding it.
